The Company will convene the second session of the 2026 Annual General Meeting of Shareholders on June 22, 2026.

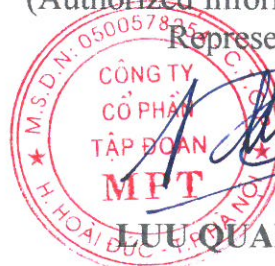

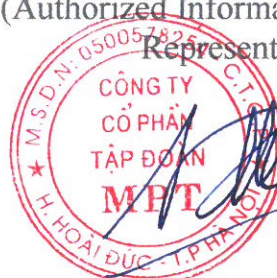
